# FACILITY APPLICATION AND PERMIT

## Tri-Valley Wildlife Area

*This portion of the application only needs to be completed by field trial clubs wishing to use the facilities at Tri-Valley Wildlife Area. Payment for use of these facilities must be submitted with the field trial permit application. Application received **without payment will not be processed nor will the requested dates be reserved.***

Each club must organize parking for the event, to ensure efficient access, that all vehicles are in the gravel area, and to avoid damage to the building and poles.**
